
Office Order

M/s Arion Healthcare has a rate contract no. 20200015901 (3-Oct-2020 to 2-Oct-2022) with this Corporation for the supply of drug "Diclofenac Sodium Inj 75mg/ml, 1ml Ampoule". Uttar Pradesh Medical Supplies Corporation Ltd. has issued purchase orders vide 10282206868 dated 13-Jun-22, 10282202467 dated 16-Mar-22, 10282105819 dated 6-Dec-21 for supply of Diclofenac Sodium Inj 75mg/ml, 1ml Ampoule to various Distt. Drug warehouse. Company had not supplied the above said purchase orders issued by Uttar Pradesh Medical Supplies Corporation Ltd. as tender terms and conditions.

Notice to the Company M/s Arion Healthcare was sent through letter vide UPMSCL/Drugs/2022/1280 dated 25/10/2022 regarding non-supply of purchase orders for Diclofenac Sodium Inj 75mg/ml, 1ml Ampoule issued by Uttar Pradesh Medical Supplies Corporation Ltd.

The Company has not given reply to the above mentioned notice till date.

Company M/s Arion Healthcare has not supplied purchase orders vide 10282206868 dated 13-Jun-22, 10282202467 dated 16-Mar-22 and 10282105819 dated 6-Dec-21 and thus company has violated the tender condition of the tender ref no. UPMSCL/Drugs-031/140 dated 21/11/2019 Section-III Clause 13. DEBARRING & BLACKLISTING, point-ii. that is "If the Supplier fails to execute at least 70% of the order quantity for any particular drug for more than two purchase orders, then the Supplier shall be debarred for supply of that particular drug for a period of two years." Hence company M/s Arion healthcare is, hereby, debarred from participating for the drug DICLOFENAC SODIUM INJ 75mg/ml, 1ml Ampoule in tenders floated by Uttar Pradesh Medical Supplies Corporation Ltd. for two years from the date of issue of this office order.
