The last date of submission of EOI is **04:00 PM on 20.04.2021**.

Terms and Conditions:

1. Valid license to manufacture/import the item(s) quoted as per specifications mentioned in the tender from the Competent Authority or FDA
2. Copy of Valid GMP & GLP/WHO-GMP certificates of manufacturing premises issued by Licensing Authority.
3. Firm has to submit **self declaration** that it has not been convicted by court of law in India.
4. EMD for participation is Rs. 1,00,000, to be submitted through RTGS/NEFT (Account Holder Name: U P MEDICAL SUPPLIES CORPORATION LTD, Account No: 39366886265, Bank Name: State Bank of India, Branch- UP Civil Secretariat, Vidhan Sabha Marg, Lucknow, Uttar Pradesh, IFSC code: SBIN0006893).
5. Performance security will be 2% of the value of the goods purchased as stated in the Purchase Order. Performance security may be furnished in form of an Account Payee BG/NEFT/RTGS from a nationalized/ scheduled bank approved by RBI. Performance security should remain valid for a period of 05 months from the date of completion of supply. Performance security has to be submitted by each successful manufacturer without any exception.
6. The supplies have to be initiated within 7 days of release of purchase order and upto 25% is to be completed within 10 days of issuance of purchase order, upto 50% is to be completed within 20 days. All the supply is to be completed within 30 days.

7. Random sample from each batch will be tested for quality by NABL/Govt. authorized Laboratory. And those lots which declared PASS by the quality control department UPMSCL will be accepted. The testing charges are to be borne by the supplier of the item.
8. A written agreement will be executed between UPMSCL & the manufacturer, to whom the contract is awarded on non judicial stamp of Rs – 500/-
9. The consignment has to be delivered to UPMSCL warehouse at Lucknow by the supplier.
10. The payments will be processed within 15 days of date of submission of bills to UPMSCL office, Lucknow. The bills will be processed only after confirmation of receiving of complete ordered quantity for the item and based on clearance report given by quality control department of UPMSCL.
